Candidates are advised to follow the following guidelines

- There are **Two** pre-defined Examination Centre
  1. Islamabad Centre (All the candidates of Islamabad Centre are instructed to reach at Al Nafees Medical College Isra University Islamabad campus Lehtrar Road, Farash Town Islamabad near to Sultana Foundation)
  2. Karachi Centre (All the candidates of Karachi centre are instructed to reach in Dow University of Health Sciences Ojha Campus Karachi)

### Important Note:

No separate call letter/admit card will be issued. All concerned candidates are directed to check their name, Roll No., Date/time and examination center and show their roll number at entry point with original NIC.

1. The Examination will be started at **10am sharp**
2. Candidates must report in examination Centre **two hours before** the examination starts, In case of failure to reach on time candidates will not be allowed to sit for the paper
3. None of the candidates will be allowed to enter in the examination hall after **09:30am**
4. Bringing Mobile phones in examination Centers is **strictly prohibited**. In case any candidates brings the mobile he/she will be responsible to secure it otherwise in case of lost, the Examination center and PNC is not be responsible for it.

5. The candidate should bring his/her own stationary (**Lead Pencil is must**), hard board/ examination board. You would not be allowed to borrow these items from other candidates.
6. Electronic notebooks, calculators and helping materials are strictly not allowed in the examination hall, if found with any one the paper of that candidate would be cancelled.
7. List of students and Roll number will be displayed on the respective examination centers.
8. All candidates must bring the following documents. No candidate will be allowed in Examination Hall, if failed to produce the following documents:
  - a) Original CNIC with its attested photocopy
  - c) Roll number

**Note:** In case of any candidate fails to complete the deficiencies mentioned in the list he/she will be dropped from the examination. Rectifications received after November 05, 2016 will not be entertained.
